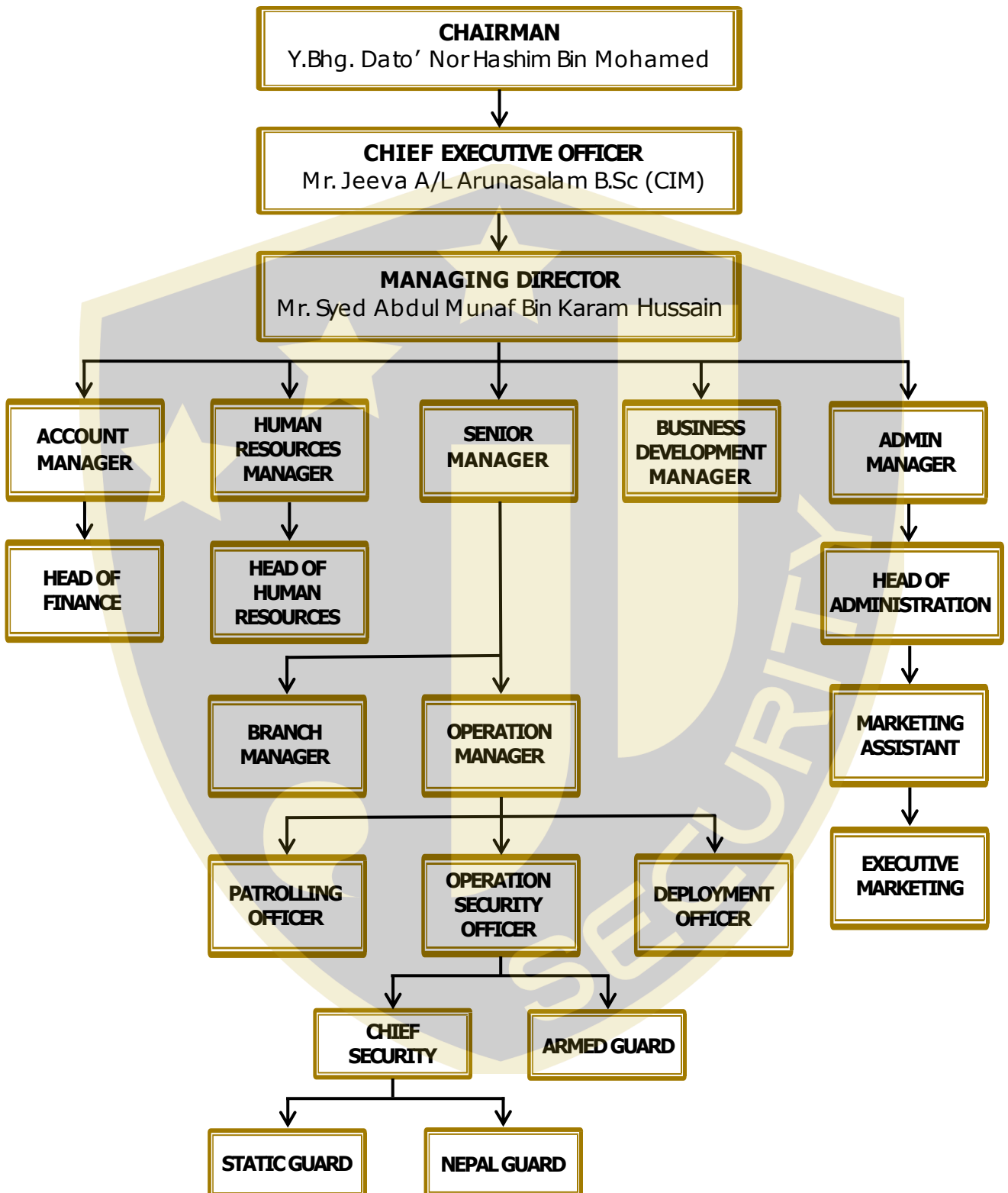
SECURITY SURVEILLANCE SYSTEM
